Call to Order:

Approval of Secretary Minutes:

 - a. Business After Hours (BAH): Tentative date set for 16 June 2021. Mr. Taro reported that he will reach out to his point of contact (POC), Josh Budrow and will build a plan for the current COVID situation and a course of action (COA) for any new set of regulations.
 - b. BAH will be a meet and greet type of event where BB and 307 will provide samples/meat platters and present their businesses and what they have to offer in terms of the sale. There will be an explanation to buyers on the ins/outs of the sale; e.g. can purchase ½ an animal and split it with another business/person, explain the buyback process, how a buyer goes about getting their animal processed, etc.

New Business:

- 1. <u>Albany County Fair Photographer</u>: Bids for photographers will be posted for consignment photos, it was discussed to have a "Fair Photographer."
 - a. "Request for Proposals"
 - i. The Albany Count Fair Board (hereinafter 'the Board) is seeking bids for photography services livestock shows and livestock exhibitors for the Albany Count Fair.
 - ii. Dates Required: 28 July 07 August 2021 (Dates must include Horse Show also)
 - iii. Scope of Services:
 - 1. Photography of exhibitors using provided backdrop
 - 2. Printable backdrop photos for each sale lot provided to the Board on USB Drive
 - 3. Live show photography for use in promotional materials for the Albany Country Fair
 - 4. Service provider will provide an image use release and digital image of 40-50 photos to the Board for marketing purposes
 - b. Submission Requirements:
 - i. Each bid submission is required to include a statement of qualifications that includes a listing of previous livestock show experiences and at least three (3) samples of professional livestock photographs.
 - ii. Each bid submission is required to include the total cost of the service. Travel and lodging expenses will not be paid separately, this should be considered in the bid price.
 - c. Proposals will be accepted until 01 May 2021 and any questions can be submitted via email to: manager@albanycountyfair.org.
